6. THE PARADE WILL NOT SUBSTANTIALLY INTERRUPT THE SAFE AND ORDERLY MOVEMENT OF OTHER TRAFFIC CONTIGUOUS TO ITS ROUTE, NOR UNDULY INTERFERE WITH PROPER FIRE AND POLICE PROTECTION OF, OR AMBULANCE SERVICE TO, AREAS CONTIGUOUS TO THE ASSEMBLY AREA, DISPERSAL AREA, OR ROUTE OF PARADE.
7. THE CONDUCT OF THE PARADE WILL NOT CAUSE INJURY TO PERSONS OR PROPERTY OR TO PROVOKE DISORDERLY CONDUCT OR TO CREATE A DISTURBANCE OR VIOLATE THE ORDINANCES OF THE CITY OF KANSAS CITY, KANSAS.
8. THIS PERMIT SHALL BE COMPLETED AND RETURNED TO THE OFFICE OF THE CHIEF OF POLICE (700 MINNESOTA AVE. KC, KS 66101) NO LATER THAN 10 DAYS PRIOR TO THE EVENT.

THE APPLICANT SHALL PROVIDE THE FOLLOWING ESCORT SERVICE AS REQUIRED BY THE CHIEF OF POLICE OF KANSAS CITY, KANSAS.

NOTICE TO PERMITEE: The parade marshal or other persons heading or leading such activity shall carry the parade permit upon his person during the conduct of the parade and shall display said permit upon request by proper officers, agents or employees of the city. The parade marshal shall monitor the parade and make himself available at all times during the parade to the Chief of Police or his designated representative. The permittee should also note that it is deemed unlawful to intentionally give false information to obtain a parade permit or to violate or fail to comply with the provisions of the Kansas City, Kansas parade ordinance.
